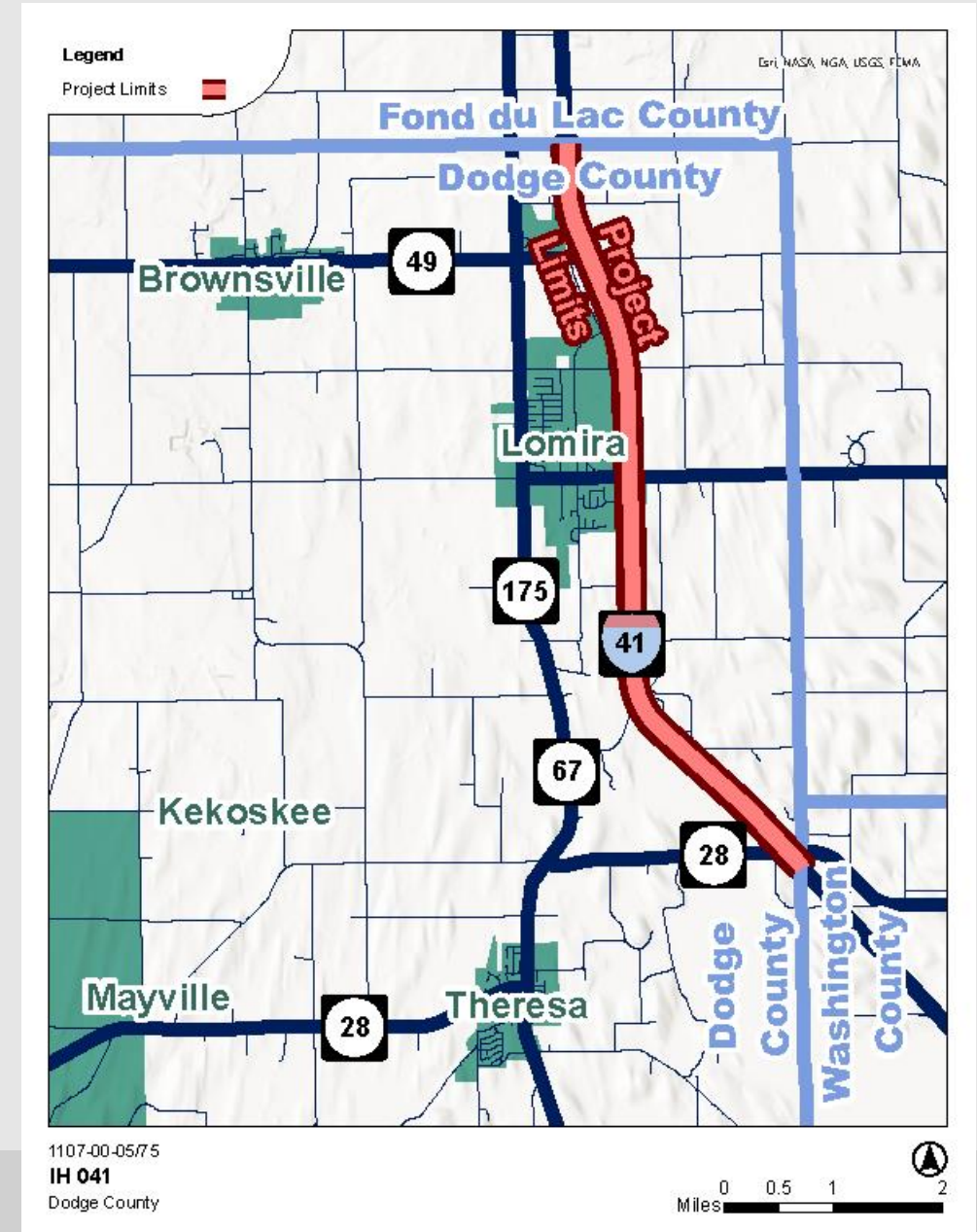

Project Purpose and Need

To preserve the roadway and structure assets for 7.3 miles of I-41

Structural deficiencies



WIS 49 over I-41(B-14-0115) – spalling between girders and deteriorating bridge deck

Roadway deficiencies



Deteriorating pavement; cracking and rutting, guardrail deficiencies, deteriorating guardrail

Proposed Improvements

Roadway

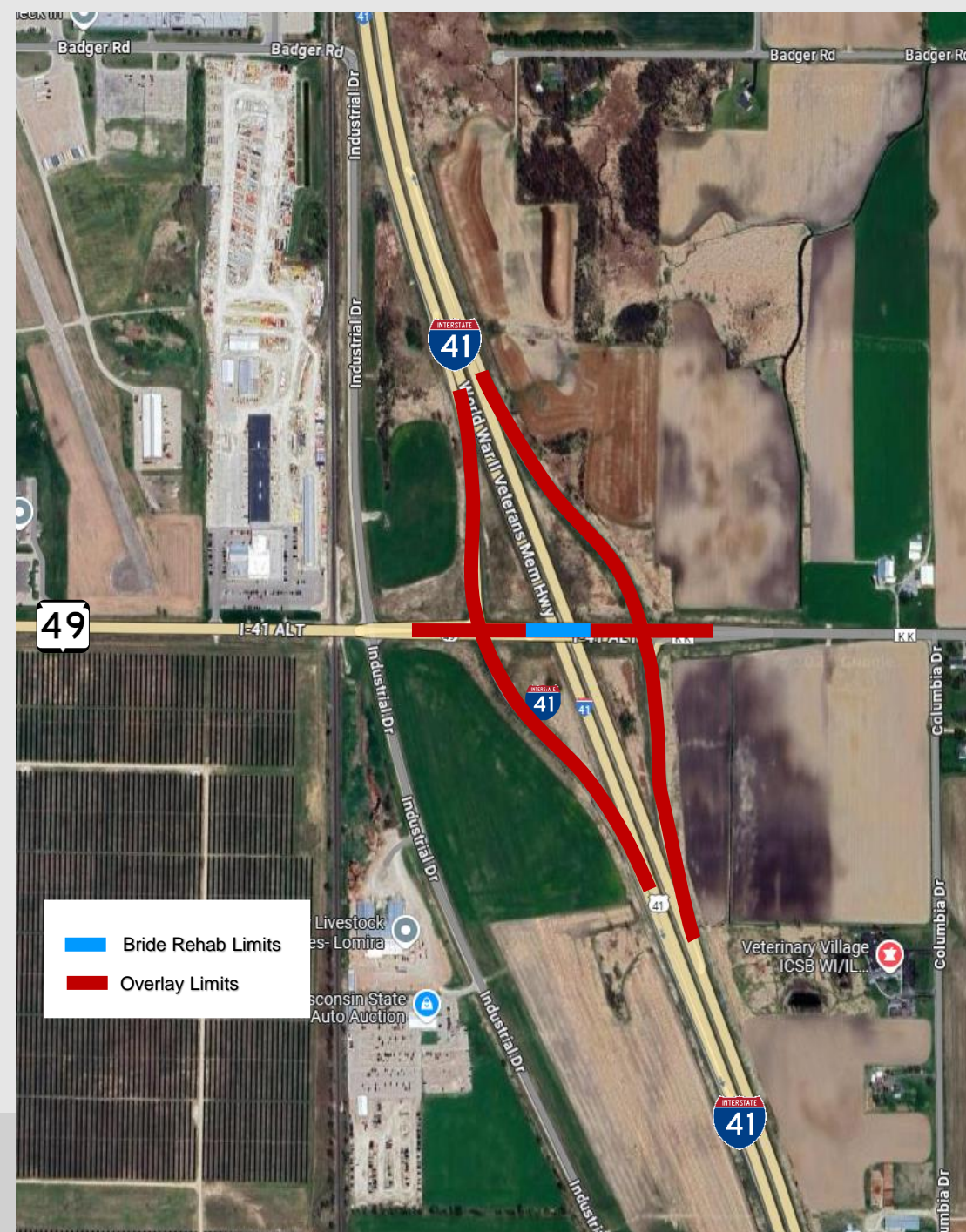
- Mill and overlay of existing asphalt on I-41
- Overlay of existing concrete on I-41
- Replace guardrail and cable barrier
- Repair culvert ends
- Culvert pipe lining



Proposed Improvements

WIS 49 Interchange

- Rehab bridge
 - Deck repairs
 - Girder repairs
 - Concrete surface repairs
 - Replace structure approach slabs
- Mill and overlay of WIS 49
- Mill and overlay of WIS 49 Ramps

WIS 67 Interchange

- Mill and overlay of WIS 67 Ramps

WIS 28 Interchange

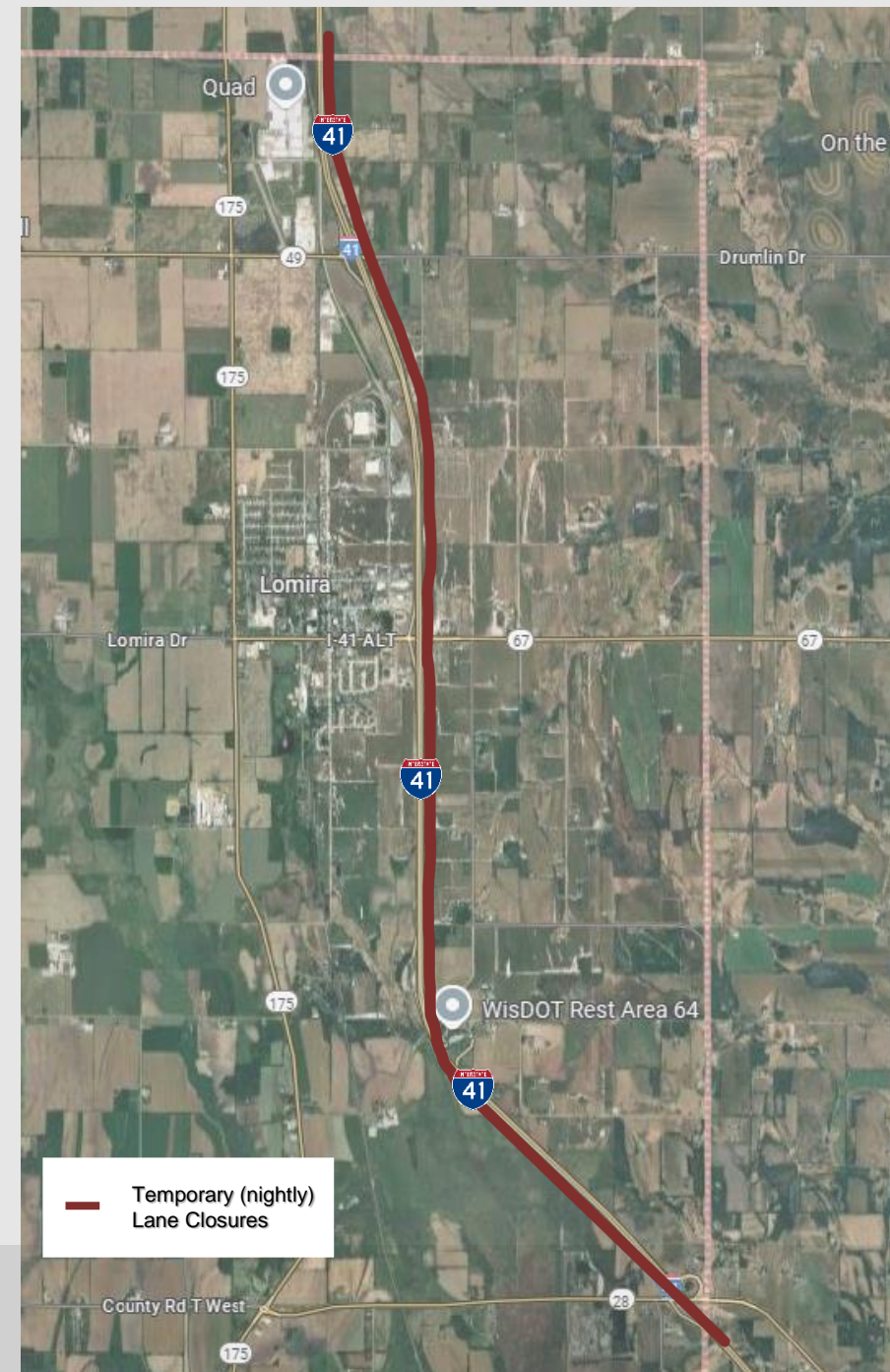

Project Impacts

I-41 Traffic Impacts

- Temporary lane closures
 - Nightly - 8pm to 7am
 - All lanes open from 7am to 8pm

WIS 49 Traffic Impacts

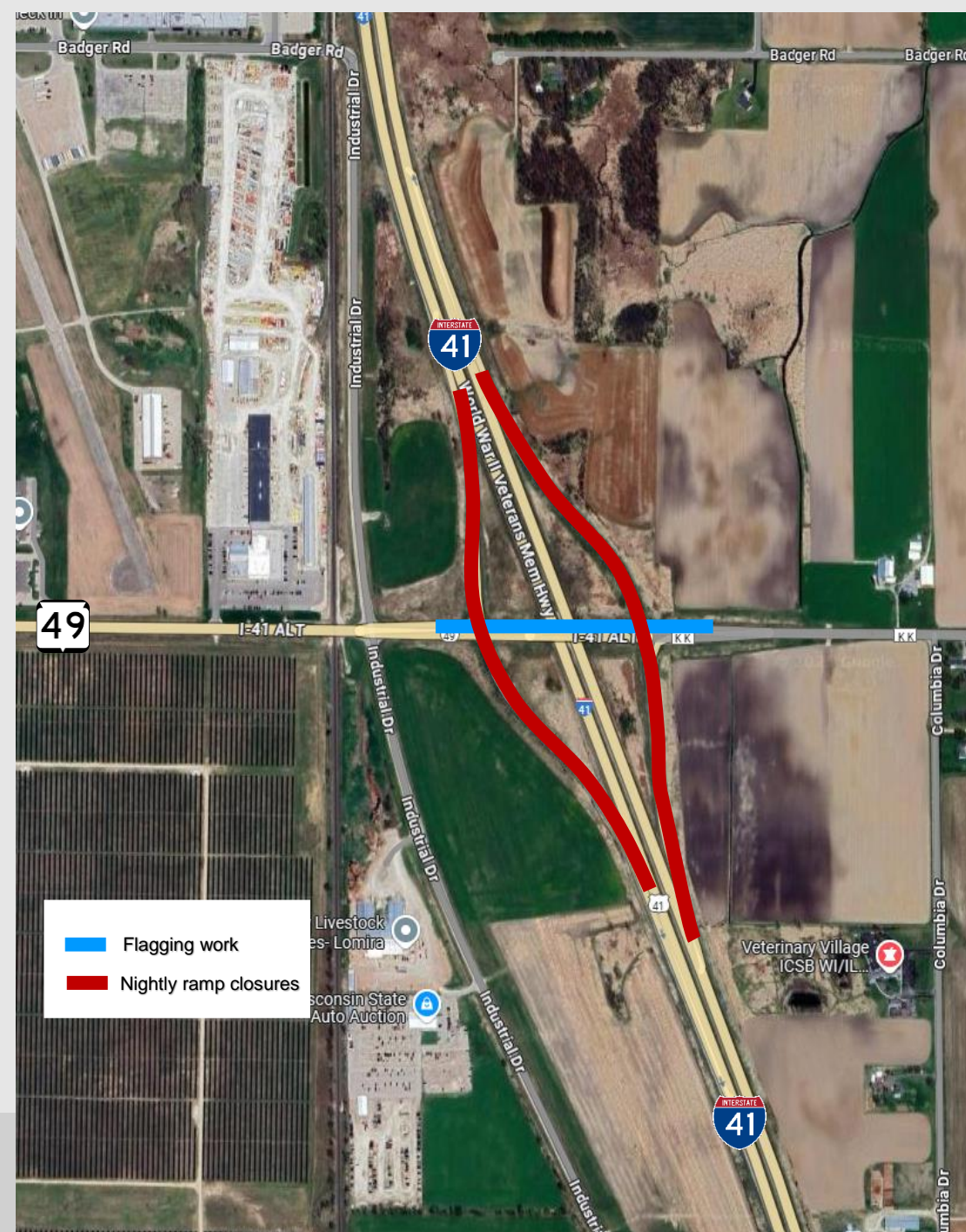
- **Bridge Work**
 - 4-to-6-week closure with detour
 - Detour: Travel to next interchange

- Roadway Work
 - Nighttime Ramp Closures



Project Impacts

WIS 28 Traffic Impacts

- Roadway Work
 - Flagging on WIS 28
 - Nighttime Ramp Closures
 - Ramp closure coordination



Project Impacts

- Right of Way impacts are **NOT** anticipated
 - Temporary limited easements (TLE) or permanent acquisition (FEE)
