






Project Limits and Definition

- This project consists of four bridge rehabilitations:
 - I-94 eastbound over I-90 westbound
 - (B-13-438)
 - I-94 eastbound over County T
 - (B-13-450)
 - I-39 westbound over US151
 - (B-13-451)
 - I-39 eastbound over US151
 - (B-13-452)



















Project Purpose and Need

 Proposed improvements on the bridge would address structural deficiencies of the existing four bridges.

























Proposed Improvements

- I-94 eastbound bridge over I-90 westbound scope includes:
 - Expansion joint replacement at each end.
 - Replacement of the approach slabs on each end (not including shoulders).
 - Spot painting of the girder ends at ends of bridge for 10 feet.
 - Guardrail replacement at both sides of the north ends and inside of the south end.

















Proposed Improvements

- I-94 eastbound bridge over County Hwy T scope includes:
 - Full replacement of southeast wing, and possibly the northwest wing.
 - Repair of the deck ends on both sides.
 - Replacement of the approach slabs and shoulders at both ends.
 - Guardrail replacement on both sides on the north end and southeast side of exit.



















Proposed Improvements

- I-39 bridges over US151 scope includes :
 - Repair of the deck at both ends
 - Replacement of the approach slabs at both ends, not including shoulders.

















Construction Impacts

- I-94 eastbound & I-39 east and westbound for the duration of the project (2-3 months):
 - Lane and ramp closures throughout construction.
 - Through traffic access would be maintained.
 - Construction would be staged.




















Construction Impacts

- Bridge and roadway work is to be completed in halves to maintain through traffic during construction.
 - Half of the roadway will be closed to traffic while construction improvements are made, with traffic utilizing the other half of the roadway.
 - The newly constructed side would then be opened to traffic while the other half is closed.

















Estimated Project Costs

- Estimated Roadway Cost
 - **\$1,126,164.00**
- Estimated Structure Costs
 - B-13-438: \$185,276.00
 - **B**-13-450: \$39,884.00
 - **B**-13-451: \$15,340.00
 - **B**-13-452: \$26,520.00
- Estimated Total with Engineering
 - **\$1,602,200.00**



















Project Schedule

- Final Design Plan Completion
 - November 2026
- Construction
 - Summer 2029 construction season
 - Work is anticipated to take approximately 45 working days (2-3 months) to complete
