Project Purpose & Need

Purpose

The purpose of this project is to address deteriorating roadway and park and ride pavement, deficient pedestrian curb ramps, and deteriorating structures.

Need

- The concrete pavement of I-94, the interchange ramps, and the pavement between the ramp terminals were constructed in 2002 and are experiencing riding issues. The pavement exhibits cracking, spalling at the joints, and corner breaks.
- The roadway shoulder pavement and park and ride pavement have also deteriorated.















Project Purpose & Need (cont.)

Need

- The curb ramps on North Watertown Street do not meet Americans with Disabilities Act (ADA) standards.
- The structures in the project area have varying levels of deterioration and identified maintenance is needed. All bridges have a high sufficiency rating and do not require reconstruction.





Design Overview

Pavement

- Concrete surface repair and spot replacement of the existing concrete pavement of I-94, the ramps, and pavement between the ramps.

 Existing shoulder pavement would be milled and overlayed with new asphalt
- pavement or replaced as needed.
- Existing asphalt pavement at the park and ride on North Watertown Street would be milled and overlaid with new asphalt.















Design Overview (cont.)

- Pedestrian Accommodations
 - Existing curb ramps adjacent to the park and ride driveway, bus stop, and along the west side of North Water Street would be upgraded to meet ADA standards.
- Bridge Structures
 - Repairs would be made to bridge structures B-28-016, B-28-017, B-28-111, B-28-112, B-28-109, and B-28-110.















Traffic During Construction

- Construction along roadways would occur during nighttime hours.
 - Work along I-94 and WIS 26 would occur using single-lane closures during nighttime hours.
 - Work along North Watertown Road would occur under a full closure during nighttime hours.
 - Ramp closures would be needed for pavement work along the ramps during nighttime hours.
 - The park and ride has a bus stop and access for the bus stop would be maintained throughout construction.

















Project Schedule

- Fall 2021–Complete environmental review process and preliminary design plans.
- Spring 2024–Finalize roadway sign plans.

Construction of the project is scheduled for 2027 with potential for construction to be advanced to 2025, if funding becomes available.
