FHWA was the Federal-Lead Agency on the Beltline PEL Study, while WisDOT was the State-Lead Agency. Throughout the Beltline PEL Study, FHWA and WisDOT were referred to as Joint-Lead Agencies. A Coordination Plan for Agency and Public Involvement (Coordination Plan) was developed to communicate how and when the lead agencies, WisDOT and FHWA, would coordinate public and agency participation and comment in the planning and environmental review processes for the Beltline PEL Study. The document was intended to be a dynamic document available to stakeholders and was updated as appropriate throughout the duration of the study. Since it was initially provided to Native American Tribes, agencies, and local municipalities in October 2013, the Coordination Plan was updated six times with the last update in September 2023. To facilitate public and agency involvement in the planning and environmental review process, a number of coordination and comment points were established. Comment points were occasions in the study process when the lead agencies requested written feedback from cooperating and participating agencies, related to draft documents. Table 2.01-1 lists the five comment points for the Beltline PEL Study.

Comment Point	Description

2	Provide written comments on development of criteria for screening (that also address social, cultural, and environmental resources) of potential corridor solutions.
3	Provide written comments on identification and dismissal of Stand-Alone Strategies.
4	Provide written comments on screening of Strategy Packages, which include multiple mode improvements to address Beltline PEL Study Objectives.
5	Provide written comments on Draft Beltline PEL Study Summary Report (including Strategies recommended for further evaluation in future NEPA documents, and identification of potential mitigation opportunities).

The Beltline PEL Study was put on hold in 2016 while WisDOT assessed planning priorities statewide. Coordination with Native American Tribes, state and federal resource agencies, and local municipalities was restarted in 2021. Following the designation of the UW–Madison Arboretum as a National Historic Landmark in January 2021, invitations to participate in the Beltline PEL Study of the Beltline were mailed to the NPS and the Advisory Council on Historic Preservation (ACHP) on September 24, 2021.

The study process included numerous meetings with agencies, TAC, PAC, local municipality committees and boards, neighborhoods, and stakeholder groups. Table 2.01-2 lists the meetings and presentations to agency and municipal organizations.
