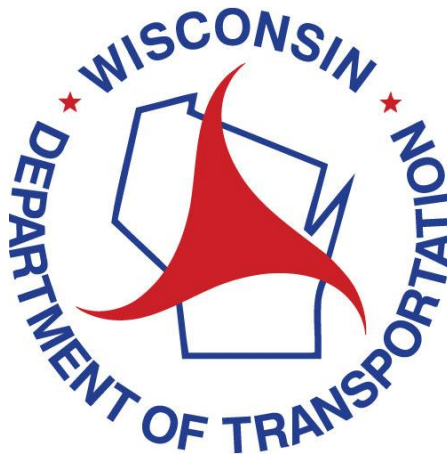

Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements of the Larkin Street/US 12 intersection in the City of Tomah, Monroe County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

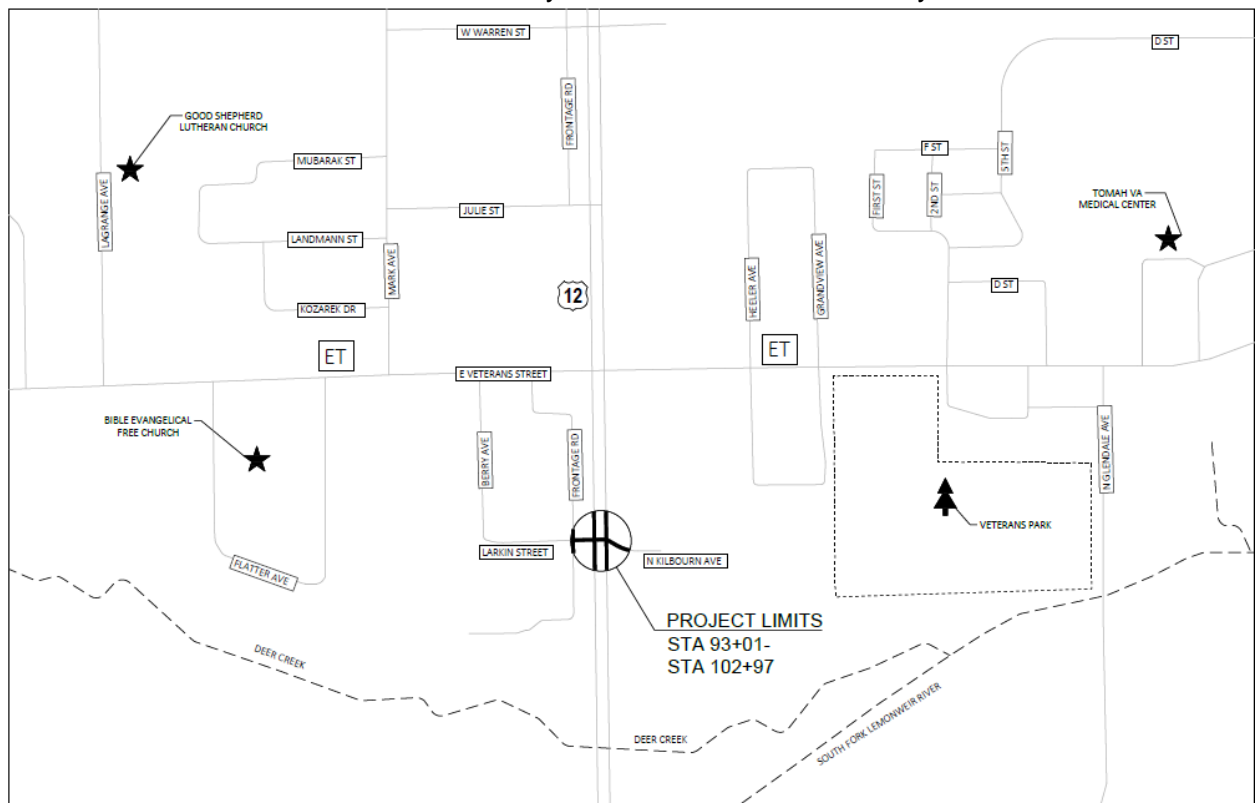
Purpose and need for roadway and bridge improvements

The purpose of the proposed project is to improve intersection safety at the Larkin Street intersection with US 12.

The existing 4-legged intersection has no left turn lanes. Over a five-year analysis, there has been eight crashes due to failure to yield from the sideroad.

Project location

Larkin Street/US 12 intersection in the City of Tomah in Monroe County.



Anticipated benefits

- Improve safety of the intersection for left turning vehicles
- Improve line of sight for vehicles exiting Larkin Street

Proposed improvements

This is a rehabilitation-level project. Proposed improvements include:

- Provide offset left turn lanes on US 12
- Provide an offset right turn lane on eastbound US 12

Traffic impacts

Construction is scheduled for 2028.

During construction, US 12 will remain open to traffic and will utilize single lane closures to complete the project work. Temporary pedestrian accommodations will be provided to facilitate users throughout the intersection during construction. Motorist can expect to encounter traffic drums, barricades, traffic control signage, and flagging operations.

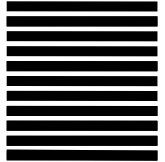
