#### **Purpose of handout**

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on US 12 in Monroe County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.


### Purpose and need for roadway and intersection improvements

The purpose of the proposed project is to replace the pavement, add an offset right-turn lane at the US 12/County O intersection, widen the paved shoulders to 5-ft paved with 1-ft gravel (existing 3-ft paved, 3-ft gravel), replace the guardrail, and replace one culvert pipe.

The project is needed because the pavement is aged and deteriorated with cracking. There have been 7 intersection crashes at US 12/County O and 7 roadway departure crashes along the roadway shoulder.

## **Project location**

US 12 in Monroe County between County O to 0.25 Miles North of the I-94 Ramp



## **Anticipated benefits**

- Improve the driving surface for daily traffic
- Improve safety at the roadway shoulders
- Improve safety at the intersection of US 12/County O

#### **Proposed improvements**

This is a pavement replacement project. Proposed improvements include:

- Replacing the pavement on US 12
- Paving 5-ft wide shoulders
- Constructing an offset right turn lane at US 12/County O
- Guardrail and culvert replacement

## **Traffic impacts**

Construction is scheduled for 2030. The project could be constructed in 2029, if funding is available. During construction, US 12 will typically remain open to traffic. Roadway flagging operations will control traffic. A short-term closure with detour may be needed while replacing the culvert pipe.

#### **Real Estate**

Real estate for this project is anticipated at the intersection of US 12/County 0. One 1,600 square foot parcel is anticipated.
