Purpose

The Wisconsin Department of Transportation (WisDOT) is planning improvements to US 14 in Viroqua to improve intersection safety for the traveling public. The project limits are the New Roadway/Walmart Intersection.

The purpose of this handout is to:

- Provide you with background information about the Walmart Intersection
- Obtain your input on potential solutions to address the existing and future transportation needs of the travelling public, local community and adjacent businesses in the area of the New Roadway/Walmart Intersection

Project information

We are proposing to improve 0.14 miles of US 14 at the intersection of US 14 and Walmart's driveway, between Brendel Lane and 400 feet south of the Walmart intersection.

The purpose of this project is to improve the US 14 and Walmart intersection safety. The project is needed due to the unsafe conditions at the intersection of US 14 and the Walmart driveway. This intersection had twenty crashes reported within a five-year analysis period, seven of which were angle crashes. Four of the seven angle crashes resulted in fatality or injury.

The objective of the public involvement for this project is to provide the public, property owners, businesses, and local officials with information regarding the project need, scope, schedule, and traffic impacts. In addition, public involvement efforts allow WisDOT to receive input from the public and address any questions or concerns about the project.

Proposed improvements include:

- Change left-turn lanes to offset left-turn lanes
- Install traffic signals
- Provide a connection to a future City of Viroqua roadway
- Replace existing curb ramps at two intersection quadrants
- Construct new curb ramps at two intersection quadrants

This Highway Safety Improvement project proposes installing traffic signals and offset left-turn lanes. Curb ramps would be updated to meet Americans with Disabilities Act (ADA) regulations. Additionally, the connection for a future City of Viroqua street would be added. The preferred alternative addresses the purpose and needs of the proposed action. This alternative would preserve the roadway assets, while maximizing the safety of the roadway corridor. Other alternatives reviewed consisted of Alternative 1: No Build. The No Build alternative does not address the purpose or need of the project, and safety risks would continue.

An environmental review, including reviewing for historical, archaeological, and potential hazardous materials is underway.

Proposed traffic impacts

Construction is currently scheduled to begin in Spring 2027 and should be completed by Fall 2027.

Proposed work will be performed while traffic is maintained on US 14 under single lane and shoulder closures. Access to adjacent properties and businesses will be maintained during construction. Sidewalk and curb ramp work will be completed utilizing temporary sidewalk closures and signed pedestrian detours.

Real estate

No additional right of way will be required for this project.

Project update/next steps

A local officials meeting was held on September 23, 2025.

Current schedule:

- September 29 to October 29, 2025: Public comment period
- December 1, 2025: Final environmental document
- November 1, 2026: Final plans, specifications and estimate submission
- 2027: Construction


