Purpose of the meeting

Welcome to the public involvement meeting for the proposed improvements to US 51 from Exchange Street to Larson Beach Road in the village of McFarland and town of Dunn.

The objective of this meeting is to provide you with updated information regarding the proposed improvements to the roadway. We are seeking your input on updates to the project design, particularly the intersection alternatives for the Larson Beach Road intersection. A brief presentation will occur at 5 pm.

Please take time to review the information presented. WisDOT project representatives are available to answer questions. A public comment form is also available for you to provide written comments. Please submit all comments by August 24th, 2022.


Project information

The US 51 corridor project in Dane County is 18.1 miles from I-39/90 to Voges Road. The US 51 corridor project was split into 11 construction projects. US 51 from Exchange Street to Larson Beach Road is programmed for construction in 2028 but could be constructed as early as 2026 if funding becomes available. Construction of the 11 individual projects will occur between 2024 and 2029.

US 51 between Exchange Street and Larson Beach Road will include the following proposed improvements:

- Reconstructing the existing 4-lane urban roadway section.
- Constructing new sidewalk, curb ramps, and crosswalks which will meet current Americans with Disabilities Act (ADA) criteria.
- Reconstructing the Yahara River bridge, including a new pedestrian underpass to Babcock Park.
- Numerous improvements within Babcock Park.
- Reconstructing the Farwell Street intersection to include offset left turn lanes, increased left turn lane storage, and upgrading signal equipment.
- Proposed alternatives for the Larson Beach Road intersection include an improved signal or roundabout.
- Continuous street lighting between Burma Road and Larson Beach Road.

Proposed traffic impacts

Construction is currently scheduled to begin in 2028 but could be constructed as early as 2026 if funding becomes available.

The project will be constructed under staged traffic. US 51 will be reduced to single lanes in either direction. The contractor will maintain access to residents and businesses during construction. If closures are required for driveway work, this will be communicated with residents or businesses in advance.

Business coordination is available through the WisDOT In This Together program. These resources help businesses with tips and tools during construction, including temporary business signage recommendations and resources such as planning worksheets. Real Estate

This project will require some right of way acquisition, but no relocations are expected. WisDOT expects to begin real estate acquisition in Fall 2023.
