

# **Purpose**

Our objective is to inform you of the Highway Safety Improvement Project purpose and need and obtain your input and feedback on the identified needs and proposed improvements located at the west junction of WIS 60 and US 61 in Crawford County, across the Wisconsin River from Boscobel (see the project location map below).



# **Project information**

This project is an 0.644-mile-long segment of US 61 from the west junction of WIS 60 and US 61 in Crawford County, across the Wisconsin River from Boscobel. US 61 is a two-lane rural highway, and the roadway is classified as a principal arterial. There have been many maintenance activities occurring since construction with the last activity being in 2016. The existing roadway surface is aged and deteriorated with rutting throughout the entire project limits. The purpose of this project is to increase the safety and extend the service life of the pavement for the users of US 61.

The need of the project is to address safety of the intersection of US 61 and WIS 60 due to the existing configuration causing poor visibility for traffic northbound US 61 stopped at the intersection.

# **Proposed Improvements**

Proposed improvements will provide an offset right turn lane for eastbound to southbound right turning traffic so northbound traffic has better visibility.

# **Proposed traffic impacts**

During construction, US 61 will remain open to motorized traffic and offset right turn lane will be constructed using a shoulder closure.

The project is currently scheduled for construction in 2029 but may be built as early as 2027 if funding is available.
