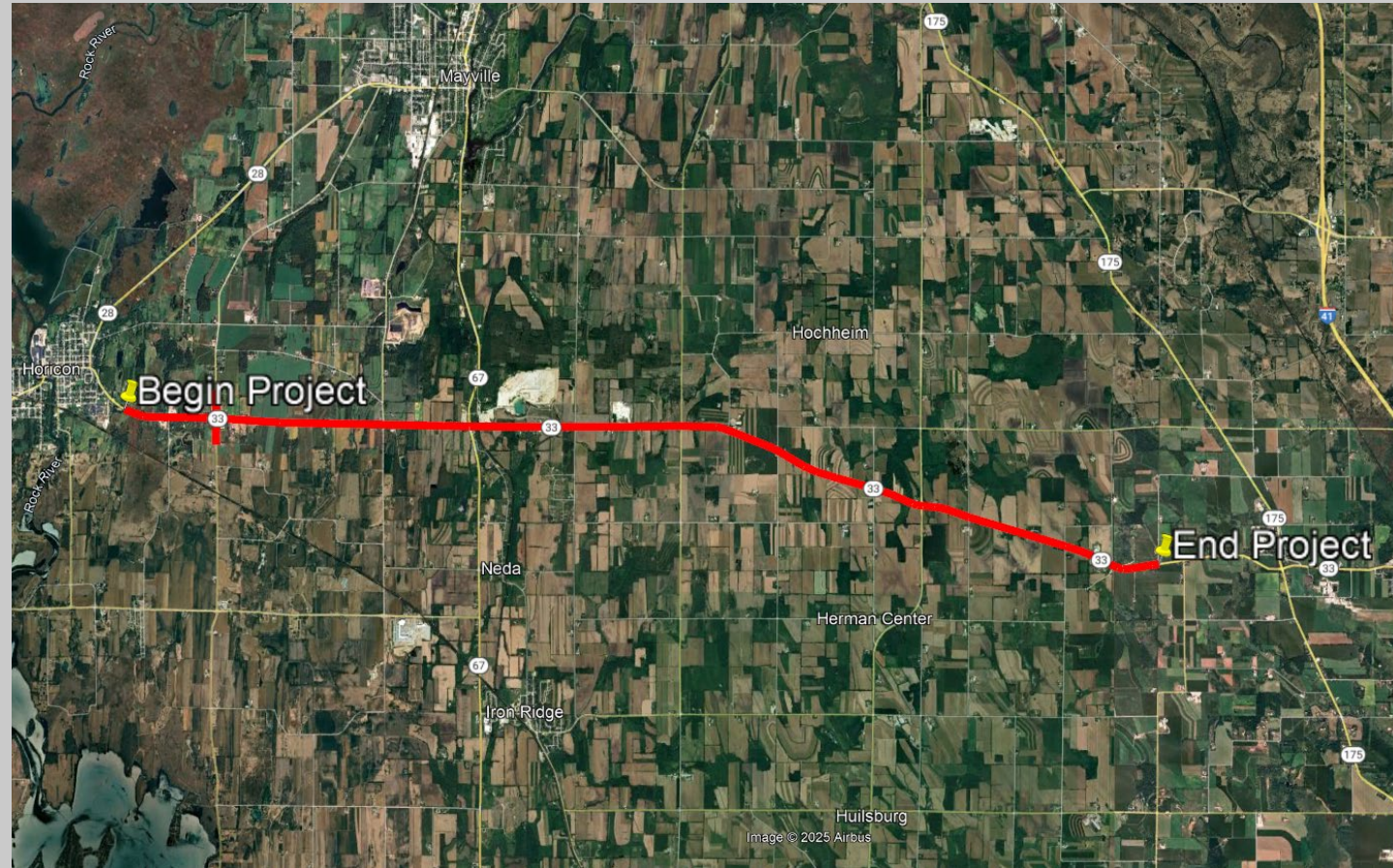

- 11.71 Miles

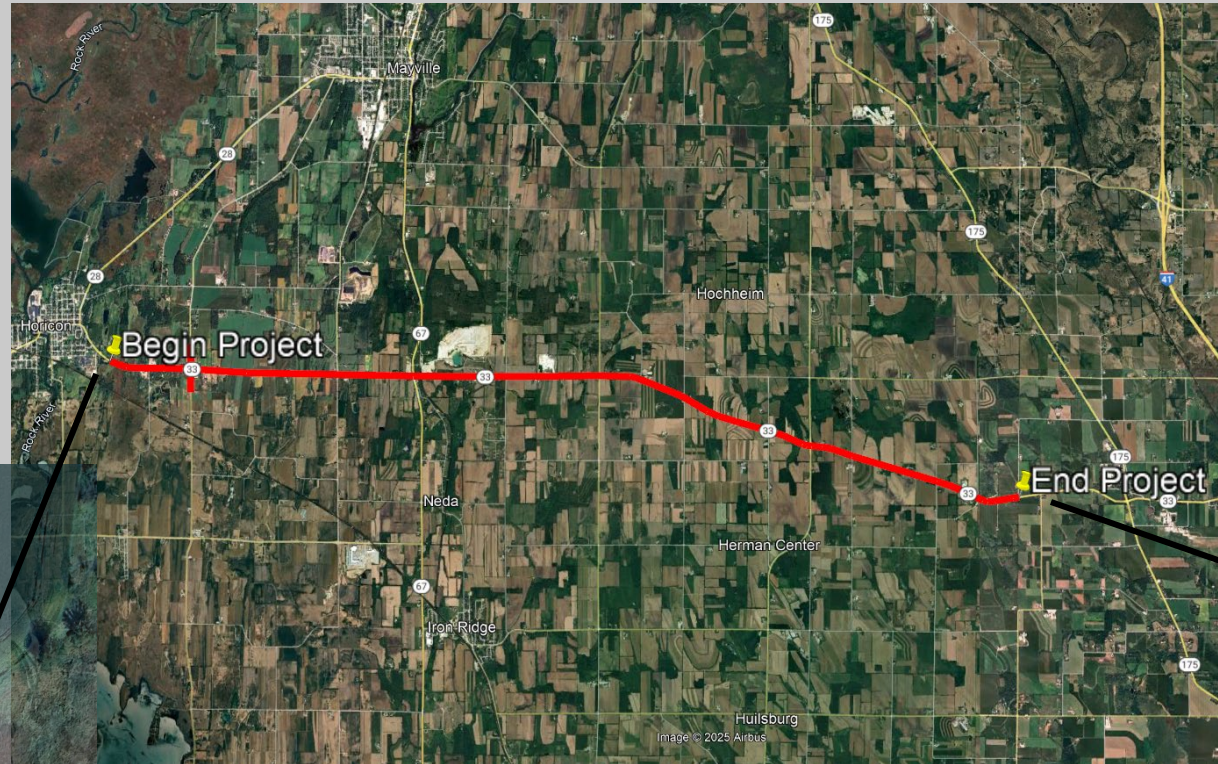

What are the project limits?



Project need

- The roadway is deteriorated with alligator, longitudinal, and transverse cracking, rutting and weathering.
- High crash rate at the intersection of WIS 33 and CTH TW
- Retaining wall deterioration
- Outdated storm sewer at the WIS 33 and WIS 67 intersection
- Substandard guardrail
- Curb and gutter deterioration



What improvements are proposed?

- Pavement replacement from Horicon City Limit to Washington County Line.
- Construction of a new roundabout at the intersection of WIS 33 and CTH TW.
- Replace and repair retaining walls just east of WIS 67.
- Storm sewer replacement at the intersection of WIS 33 and WIS 67.
- Replace all guardrail throughout the corridor.
- Replacing curb and gutter throughout the project limits.



What improvements are proposed?

Pavement Replacement

Easterly Horicon City Limit to Washington County Line, excluding the roundabout at WIS 33 and CTH P and WIS 67 intersection:

- Remove 6.5 inches of existing asphalt to the existing aggregate base and replace it with 7 inches of new asphalt
- Extend the paved shoulder from 3' to 5', with the addition of shoulder rumble strips
- Add centerline rumble strips



What improvements are proposed?

Pavement Replacement

Existing roundabout at the intersection of WIS 33 and CTH P:

- Mill and overlay 2.5 inches of asphalt

WIS 33 and WIS 67 intersection

- Remove existing asphaltic pavement and place 10-inches of concrete pavement

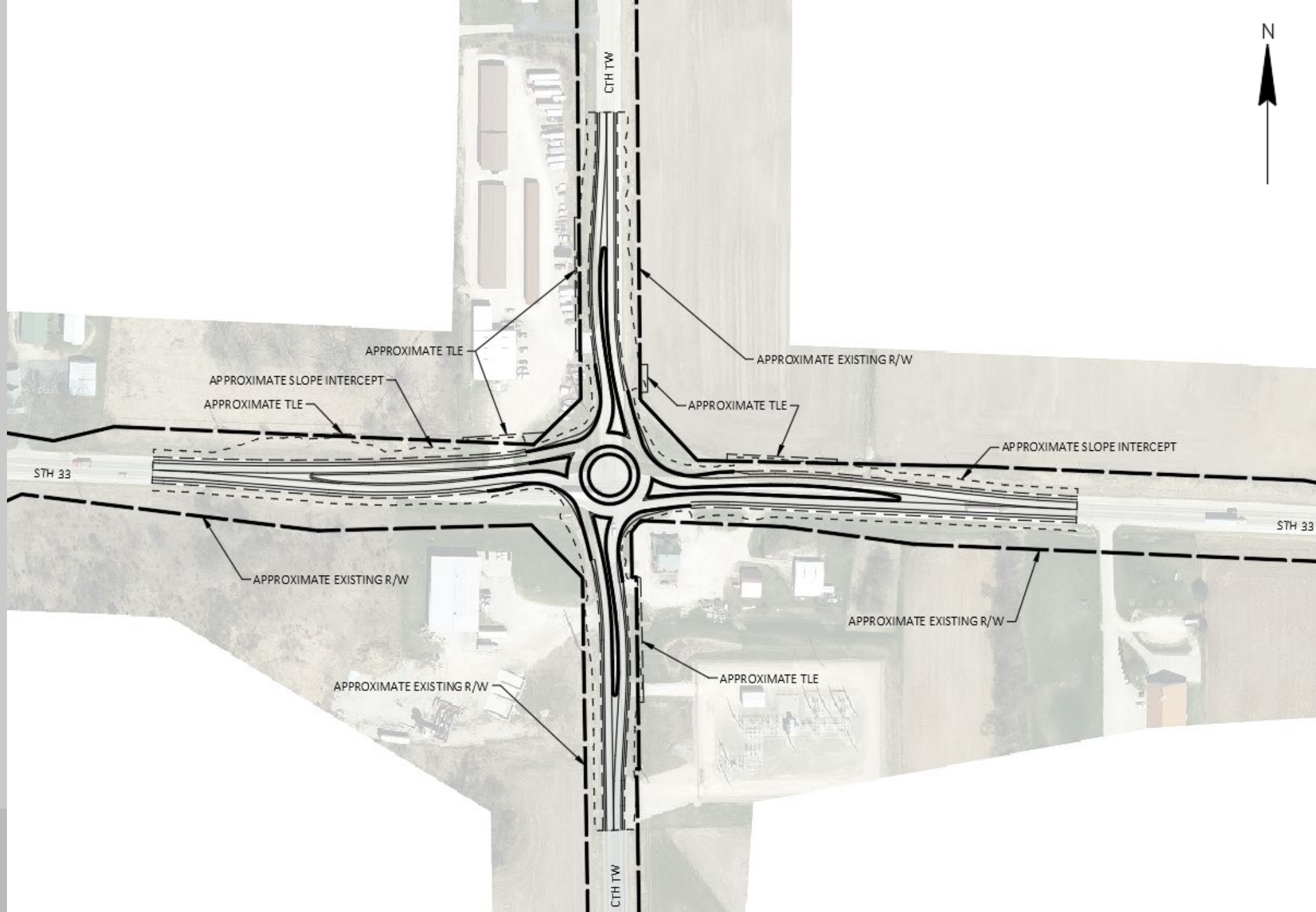


What improvements are proposed?

WIS 33 and CTH TW Intersection Roundabout

- Construct a high-speed single lane roundabout
- Addition of storm sewer to maintain drainage patterns





What improvements are proposed?

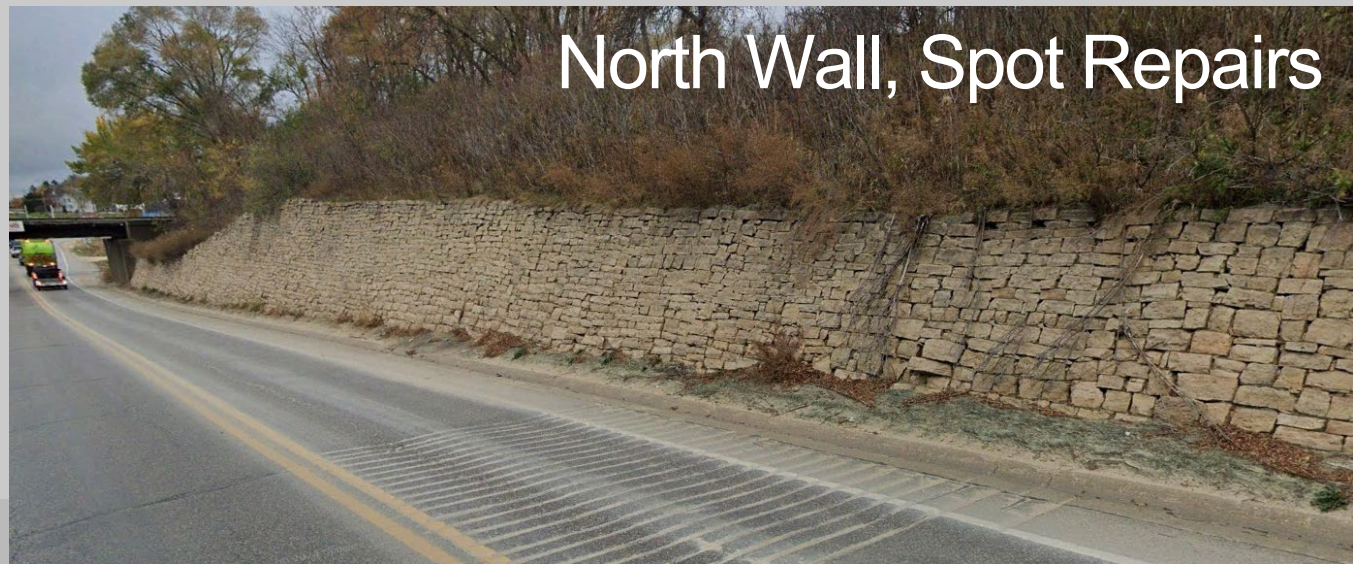
Retaining walls between CTH V and Madison Road

- Full replacement of south retaining wall
- Spot repair of the north retaining wall

What improvements are proposed?

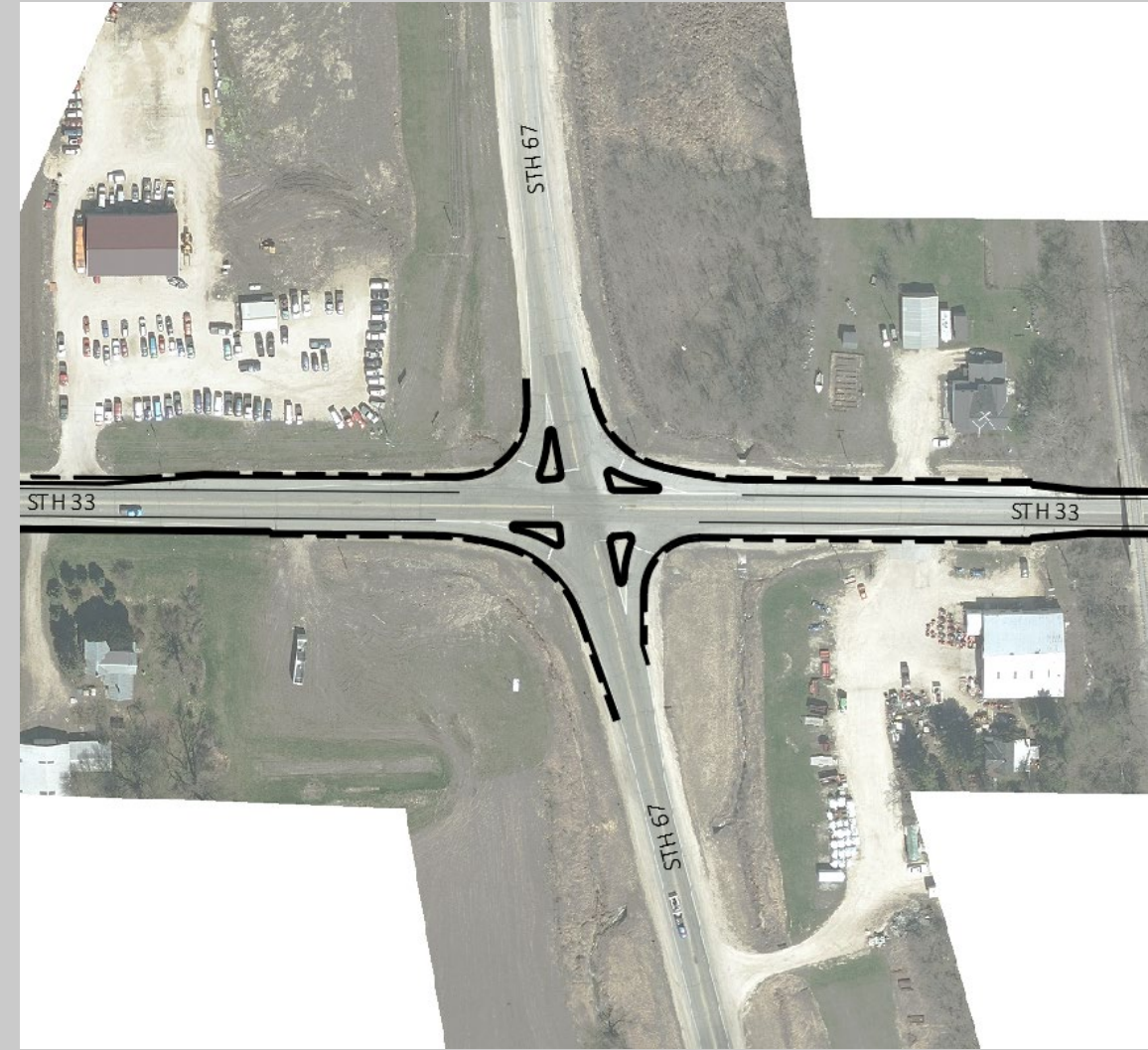
Storm Sewer improvements

Storm Sewer replacement at WIS 67 and WIS 33 intersection

- Pork chop turn lane replacements

Culvert Replacements - Reinforced Concrete Cylinder Pipe (RCCP)

- East leg of CTH V intersection
- 1200' east of CTH V intersection
- 2200' west of CTH AY intersection



What improvements are proposed?

Replace guardrail throughout the corridor

- West of CTH V: 750' replacement along north side of WIS 33
- West of Madison Road: 375' replaced with concrete barrier wall along north side of WIS 33
- West of Dakota Road: 725' replacement along north side of WIS 33.

Real estate impacts

- Possible Fee Title and Temporary Limited Easements (TLE) may be required for the roundabout construction at WIS 33 and CTH TW, the south retaining wall east of WIS 67, and the three guardrail replacement locations.
- WisDOT will be coordinating with property owners for any permanent or temporary real estate needs



What will happen to WIS 33 traffic?

From Horicon City Limit to Washington County Line:

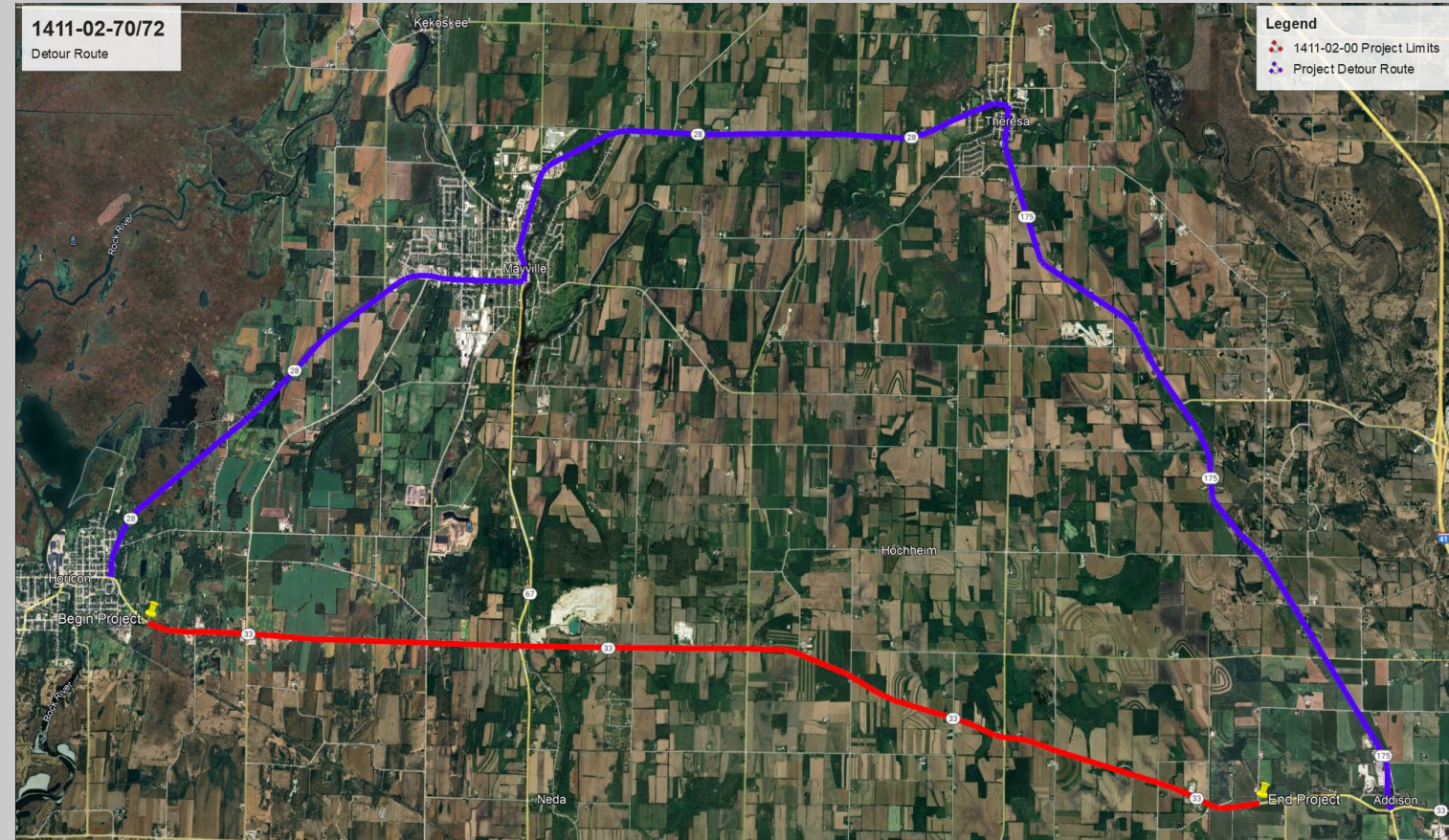
- WIS 33 will be closed to through traffic, with access for residents, businesses and emergency vehicles requiring access to the corridor.
- Coordination with townships to have signage on town roads.



What will happen to WIS 33 traffic?

Proposed Detour Route:

- WIS 28 to WIS 175
- Estimated detour duration is 5-6 months

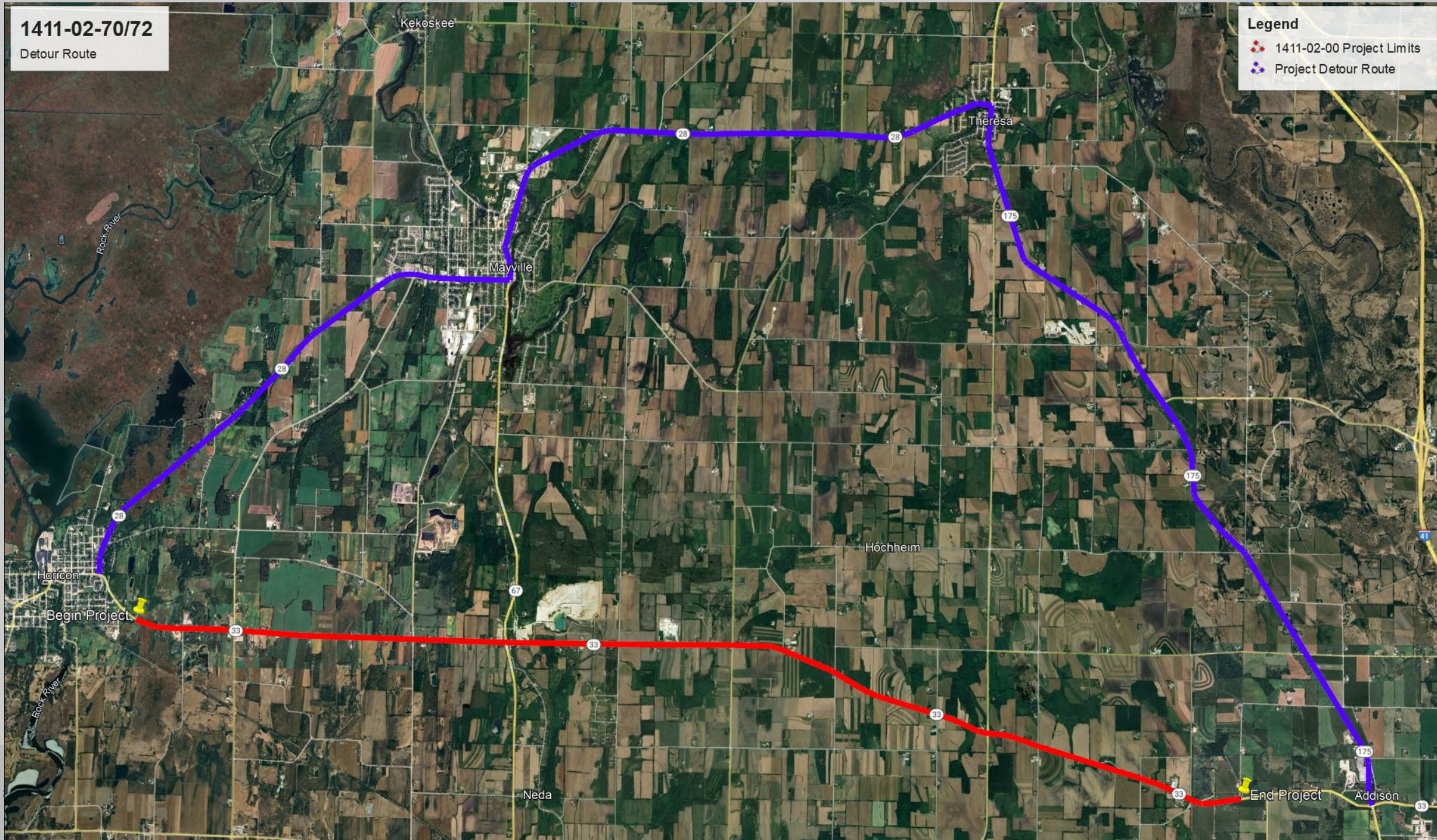

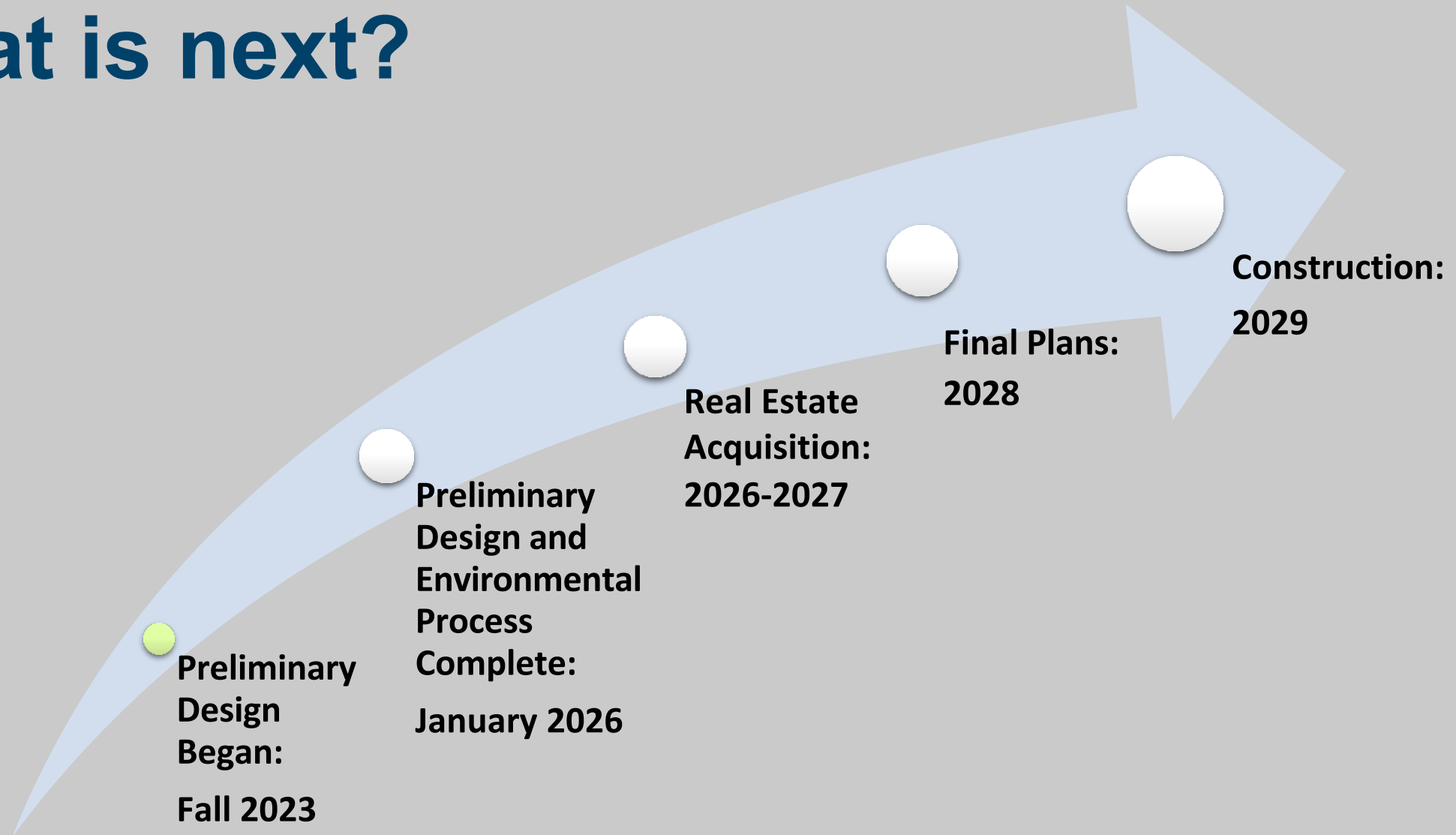
Detour Route

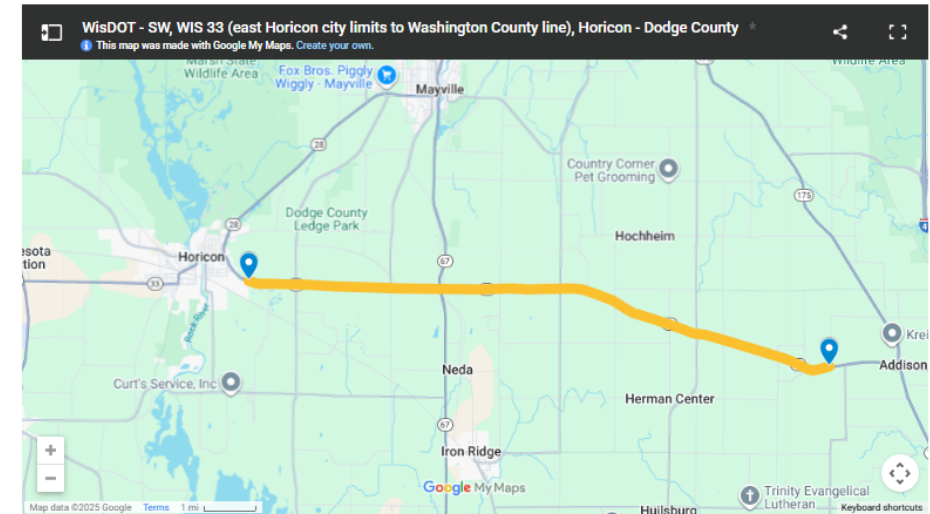
