Purpose of the meeting

Welcome to the WIS 80 (S Fork Baraboo River Bridge to WIS 33) and WIS 33 (Hillsboro City Limits to County HH) public involvement meeting.

The Wisconsin Department of Transportation (WisDOT) is planning improvements to WIS 80/WIS 33 in the Hillsboro area to address the deteriorating pavement. Our objectives for today's meeting are to update the public on the status for the project and to obtain input on the proposed improvements.

The purpose of this project is to replace the pavement structure of WIS 80 and WIS 33 and update sidewalk curb ramps to meet current ADA standards. The existing pavement has extensive alligator cracking, edge cracking, longitudinal and transverse cracking.

Coordination with Local Officials took place immediately prior to this public involvement meeting.

There will be a short 10-minute presentation at about 5:30pm, after which there will be an open-house format.

Project information

WisDOT is proposing to improve 0.59 miles of WIS 80 between S Fork Baraboo River Bridge and WIS 33 and 1.03 miles of WIS 33 from the City of Hillsboro West Limits to County HH. Proposed improvements include removal and replacement of existing pavement and updating all sidewalk curb ramps to meet current ADA standards.

Proposed traffic impacts

Construction is scheduled for 2028-2029.


During construction, a full road closure will be required to complete the pavement replacement and a detour will be provided for through traffic. The WIS 33 and WIS 82 detour route will utilize WIS 131 and WIS 71. The WIS 80 detour route will utilize WIS 58 and WIS 23. Work within the project limits will be phased to minimize disruption to local traffic.

Temporary driveway closures will be necessary during parts of the construction process. WisDOT will contact homeowners and businesses in advance before closing a driveway.

Temporary Limited Easements and right-of-way acquisitions will be required for curb ramp work. WisDOT expects to begin real estate negotiations in October 2025.
