  3. AADT estimates for counties not counted in 2009 growth factored by the statewide growth factor average (1.02 in 2009).
  4. County-level VMT estimates most accurate for those counties actually counted in 2009 (as highlighted).
  5. Approximately one-third of Milwaukee County counted every year.
  6. Outlier traffic counts -- due to construction detours or other special events -- can significantly effect county level VMT, especially in the lower volume counties.
