## KEV CALLIJ CHOJ TSHAIS CHAW ZOO IB YAM (49 C.F.R. pt. 24)

Tsoom fwv tsab cai Uniform Relocation Assistance and Real Property Acquisition Policies Act (URA) yuav coj los siv thaum feem tau txais tes hauj lwm tau peev nyiaj los ntawm tsoom fwv txoj kev pab cuam. **NCO NTSOOV:** Daim ntawv txuam yuaj no tsis ntsees rau lub xeev tsab cai tshais chaw. Kev them nyiaj thiab kev pab tej zaum yuav txawv li hauv URA. Feem ua txoj hauj lwm tshais chaw yuav tsum qhia cov yuav raug tshais chaw seb lawv puas muaj cai raws URA.

## LUS OHIA

Yog thaum ib feem twg yuav ua ib tes dej num txhim kho rau nom tswv, nws yuav tau tshem tej neeg tawm ntawm lawv tej vaj tsev lossis liaj teb. Yog tias nom tswv cov tes dej num yuav tau tshem koj, feem uas tuaj tshem yuav tsum npaj yam muaj txiaj ntsim thiab pab cuam txhawm rau koj tsis ntsib kev puas tsuaj loj thiab kev nyuab. Daim ntawv txuam yuaj no npaj rau koj kom paub txog koj li kev muaj cai, dhau ntawm qhov them nyiaj uas ib txwm yuav coj los siv rau cov dej num nom tswv, yog tias koj yuav tau tshais tawm ntawm koj qhov chaw lag luam lossis liaj teb.

Feem tuaj ua txoj hauj lwm tshem cov neeg yuav tsum qhia cov txheej xwm tshais cov tswv av thiab cov neeg uas yuav raug tshais ua ntej yuav tshais chaw.

Yog tias muaj kev txiav txim rau tes dej num uas yog muaj kev thov yuav av thiab tshais neeg tawm, yuav tsum tau ua cov hauv qab no: (1) cov txheej xwm txog kev pab tshais chaw thiab kev them nyiaj; (2) ib tsab ntawv qhia tias feem tau txais tes hauj lwm yuav tsum npaj cov phiaj xwm tshais chaw mus rau DOA ua tus pom zoo txhawm rau yuav thiab cov neeg uas ntxim li yuav raug kev puas tsuaj los ntawm tes dej num yuav raug tiv tauj txhawm rau tau cov txheej xwm los npaj qhov phiaj xwm; (3) qhia tus ciam ntawm tes dej num thiab

kwv yees seb muaj pes tsawg lub tsev thiab pes tsawg yam uas tsis yog tsev uas yuav tau muas; (4) ib tsab ntawv qhia tias yog leej twg ho tshais mus ua ntej tej zaum kuj yuav tsis tau txais txiay ntsim kev tshais chaw thiab yuav muab lub sij hawm txaus los tshais chaw; thiab (5) npe, chaw nyob thiab xov tooj ntawm feem ua txoj hauj lwm tshais chaw txhawm rau tau hu tiv tauj yog muaj lus nug.

Thaum feem ua txoj hauj lwm tshais chaw tiv tauj thawj zaug ib tug tswv txhawm rau thov cov txheej xwm uas yuav tau siv npaj rau kev tshais chaw, nws yuav tsum tau muaj cov txheej xwm hauv qab no: (1) ib qho qhia meej txog tes dej num uas yuav npaj ua; (2) ceeb too rau cov tswv tias tab tom tiv tauj cov xob es kom tau cov txheej xwm los npaj qhov phiaj xwm; (3) ceeb toom rau cov tswv av kom tsum cov neeg xob ua ntej thov yuav; (4) piav qhia rau cov xob tias kom lawv tsis txhob rawm maj tawm ua ntej txog lub caij; thiab (5) ceeb toom yog tias cov xob tawm ua ntej txog lub caij thov yuav, tus tswv tej zaum yuav tau tus nqi xob uas poob mus lawm.

Feem ua txoj hauj lwm tshais chaw yuav tsum muab cov ntaub ntawv hauv qab no rau tus tswv thiab tus xob cov vaj tsev thiab av: (1) ib daim ntawv hais txog tes dej num uas yuav npaj ua; (2) ceeb toom txog kev tawm ua ntej tej zaum yuav tsis tau qhov pab tshais chaw; (3) hnub ua yuav pib; (4) ib qho qhia txog tag nrho kev tshais chaw thiab cov txiaj ntsim yuav tau txais; thiab (5) cov txheej xwm tiv tauj feem ua txoj hauj lwm tshais chaw yog muaj lus nug dab tsi.

## PHIAJ XWM TSHAIS CHAW

Feem ua txoj hauj lwm tshais chaw tshais chaw yuav tau npaj, xa thiab coj mus cov phiaj xwm rau DOA pom zoo ua ntej pib kev sib tham yuav cov av. Qhov phiaj xwm lub hom phiaj txhawm rau npaj nyiaj kom txaus thiab kev pab kom txaus los pab tshais chaw, thiab tsom xam seb cov chaw puas txaus rau cov neeg uas yuav tshais chaw.
