*Replace the third paragraph under section titled **Alliant Energy (electricity)** with the following:*

The anticipated start date for work to be performed by Alliant Energy is January 9, 2017. The estimated construction time required is 60 working days.

*Replace the third paragraph under section titled **Charter Communications (communication line)** with the following:*

The anticipated start date for work to be performed by Charter Communications is February 27, 2017. The estimated construction time required is 30 working days.

*Replace the third paragraph under section titled **McLeod Telecommunication Services Inc (communication line)** with the following:*

The anticipated start date for work to be performed by McLeod Telecommunications is March 1, 2017. The estimated construction time required is 30 working days.

*Replace the third paragraph under section titled **Sheboygan Water Utility (water)** with the following:*

Sheboygan Water Utility will complete the following work during construction:

- Lower the existing 16-Inch water main at 6+40 RT and 21+90 LT after the pavement has been removed. The work is anticipated to take 2 working days to complete at each location. Notify Sheboygan Water Utility 5 working days prior to beginning storm sewer installation operations at each location.

*Replace the third paragraph under section titled **Wisconsin Public Service Corporation (gas/petroleum)** with the following:*

The anticipated start date for work to be performed by Wisconsin Public Service is October 3, 2016. The estimated construction time required is 50 working days.


