**BIDDERS MUST SUBMIT BIDDING PROPOSALS NO LATER THAN 9 A.M. LOCAL TIME, TUESDAY, February 14, 2017,** to the Division of Transportation System Development for the highway work hereinafter described. **PROPOSAL GUARANTY**
