The bidder declares that all of the said work will be performed at their own proper cost and expense, that they will furnish all necessary materials, labor, tools, machinery, apparatus, and other means of construction in the manner provided in the applicable specifications and the approved plans for the work together with all standard and special designs that may be designed on such plans, and the special provisions in the contract of which this proposal will become a part, if and when accepted. The bidder further agrees that the applicable specifications and all plans and working drawings are made a part hereof, as fully and completely as if attached hereto.

STSP'S Revised January 7, 2022 SPECIAL PROVISIONS

1. General.

Perform the work under this construction contract for Project 8040-01-74, St Croix River – Grantsburg, St Croix River Bridge B-07-0020, STH 70, Burnett County, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation, Standard Specifications for Highway and Structure Construction, 2022 Edition, as published by the department, and these special provisions.

If all or a portion of the plans and special provisions are developed in the SI metric system and the schedule of prices is developed in the US standard measure system, the department will pay for the work as bid in the US standard system.

2. Scope of Work.

The work under this contract shall consist of Structure B-07-0020, concrete masonry, concrete pavement approach slabs, excavation common, base aggregate dense, asphaltic surface, riprap, guardrail, marking, and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

3. Prosecution and Progress.

Begin work within 10 calendar days after the engineer issues a written notice to do so.

Provide the time frame for construction of the project within the 2023 construction season to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Assure that the time frame is consistent with the contract completion time. Upon approval, the engineer will issue the notice to proceed within 10 calendar days before the beginning of the approved time frame.

To revise the time frame, submit a written request to the engineer at least two weeks before the beginning of the intended time frame. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

Roadway Names

Minnesota Highway 70 (MN 70) runs concurrent with Wisconsin State Trunk Highway (STH) 70 on the border bridge. These special provisions refer to the roadway as STH 70. All provisions denoting STH 70 shall also apply to MN 70 and the approach work within Minnesota.

National Park Service Coordination

The National Park Service (NPS) owns lands along the St. Croix River, and they are responsible for managing recreational uses within the St. Croix National Scenic Riverway (Riverway) which includes the adjoining lands and the St. Croix River.

Maintain access to NPS lands at all times from STH 70. Control work operations and do not complete work outside the existing highway right-of-way on NPS lands or within NPS facilities except where allowed by a Special Use Permit.

The department has obtained a Special Use Permit from the NPS to allow work in the northwest corner of the bridge to complete restoration in the area of the existing riprap located on NPS land. Complete the work early in the project schedule to allow for vegetation to establish during other project work and remove erosion control devices (silt fence, etc.) on NPS lands prior to completing the work under this contract. The contractor shall comply with the conditions of the Special Use Permit including naming the

United States of America an additional insured party for work on NPS lands. A copy of the Special Use Permit can be obtained from Jeff Saxby at (608) 380-2805.

NPS facilities within or adjacent to the project area should not be used for contractor staging of equipment or project materials, parking of vehicles, and/or portable sanitary facilities for the workers. If any NPS lands are desired for use by the contractor (not anticipated or required by the department), the contractor would be required to coordinate directly with NPS and obtain a Special Use Permit from NPS (typically requires a minimum 90-day lead time).

Finish all areas on the project with native seeding (No. 70) and non-netted erosion mats. Netted erosion mats are not allowed. No mulching items are included in the contract, however if mulch is placed for any reason by the contractor, all mulch shall be certified weed-free mulch.

Coordinate with the local NPS representative throughout construction to coordinate activities over the St. Croix River. Establish clear lines of communication during the preconstruction meeting. The NPS construction contact will be Facility Manager, Mark Denker, (715) 483-2250, mark_denker@nps.gov. Confirm the NPS representative during the preconstruction meeting.

For all emergencies within the NPS Riverway:

- In case of injury or other situation requiring emergency response, dial 9-1-1.
- For all other emergencies within the Riverway or to report resource damage or issues; please call the NPS Riverway Dispatch at 1 (800) PARK-TIP.

WDNR and MNDNR State Forest Coordination

WDNR Governor Knowles State Forest and the MNDNR Chengwatana State Forest are located adjacent to the project area. Maintain access to the state forest lands at all times. Control work operations and do not complete work outside the existing highway right-of-way.

Minnesota State Water Trail Coordination

The St. Croix River is also managed as a State Water Trail by MnDNR. Post any applicable construction warnings at nearby public access points.

Prior to construction, contact Mary Straka, MnDNR, Parks and Trails Division Supervisor at (218) 460-7024, mary.straka@state.mn.us, to post information regarding the construction on the St. Croix River State Water Trails webpage and map.

Small Animal Protection

Install all silt fence with small animal turnarounds as shown on the plans. Monitor the work area for any nesting turtles and remove turtles outside the work area.

Riprap repair adjacent to the St. Croix River

Provide riprap materials according to standard spec 606.2.1 to replace the missing riprap at the abutments except that waste concrete material per standard spec 606.2.1(3) will not be allowed.

Clean all riprap and select crushed materials of all dirt, debris, and dust prior to placement.

Place materials with equipment located on the bridge deck or the abutment slopes under bridge. Hand placement may be required to fill in missing areas designated on the plan or by the engineer. Place all materials above the ordinary high-water mark of the St. Croix River.

Do not operate machinery within adjacent wetlands or on the streambed of the St. Croix River.

Fish Spawning - In-Water Working Restriction

There shall be no instream disturbance of St. Croix River including dropping any debris.

Little Brown Bat (Myotis Iucifugus)

Little Brown Bats have the potential to roost in the expansion joints on both of the bridge approaches. To avoid impact to roosting bats, install bat exclusion prior to April 1. Place a barrier to cover all gaps and spaces (i.e., plywood with foam back or other approved method) on each abutment to exclude bat entry into the expansion joint and the space between the abutment backwall and girder ends.

Provide a plan for the bat exclusion to the department for review and approval at least 30 calendar days prior to completing the work.

If an individual bat or active roost is encountered during construction operations, stop work and notify the engineer and the WisDOT Regional Environmental Coordinator (REC).

The work to preclude the bats from the expansion joint is incidental to items of work required for replacement of the existing expansion devices.

Working days will not be assessed for placement of bat exclusion.

Northern Long-eared Bat (Myotis septentrionalis)

Northern Long-eared Bats (NLEB) have the potential to inhabit the project limits because they roost in trees. Roosts may not have been observed on this project, but conditions to support the species exist. The species and all active roosts are protected by the Federal Endangered Species Act. If an individual bat or active roost is encountered during construction operations, stop work and notify the engineer and the WisDOT Regional Environmental Coordinator (REC).

According to the final 4(d) rule issued for the NLEB, the department has determined that the proposed activity may affect, but will not result in prohibited take of the NLEB. The activity involves tree removal but will not occur within 0.25 miles of a known hibernacula, nor will the activity remove a known maternity roost tree or any other tree within 150 feet of a known maternity roost tree.

If additional trees need to be removed, no Clearing shall occur without prior approval from the engineer, following coordination with the WisDOT REC. Additional tree removal beyond the area originally specified will require consultation with the United States Fish and Wildlife Service (USFWS) and may require a bat presence/absence survey. Notify the engineer if additional Clearing cannot be avoided to begin coordination with the WisDOT REC. The WisDOT REC will initiate consultation with the USFWS and determine if a survey is necessary.

Submit a schedule and description of Clearing operations with the ECIP 14 days prior to any Clearing operations. The department will determine, based on schedule and scope of work, what additional erosion control measures shall be implemented prior to the start of Clearing operations, and list those additional measures in the ECIP.

4. Traffic.

General

Maintain at least one lane of traffic with a minimum clear width of 12 feet at all times. Control and reduce traffic to one lane with the use of flagging operations or temporary traffic signals to complete the work. One lane conditions may remain in place during the period identified in the Holiday and Special Event Work Restrictions.

Traffic staging during work operations on Structure B-07-0020 is as follows:

- Stage 1/2 Locate traffic partially on the eastbound travel lane/shoulder and place pedestrians on the bridge along a protected route. Complete work on the left bridge sidewalk.
- Stage 3 Locate traffic partially on the eastbound travel lane/shoulder and complete work on the left side of the roadway centerline on the east half of the bridge including the left side of the Wisconsin roadway approach.
- Stage 4/5 Locate traffic partially on the westbound travel lane/shoulder and complete work on the right side of the roadway centerline on the bridge and complete the right side on the Wisconsin and Minnesota roadway approaches.

 Stage 6 – Locate traffic partially on the eastbound travel lane/shoulder and complete work on the left side of the roadway centerline on the west half of the bridge including the left side of the Minnesota roadway approach.

Do not close shoulders on both sides of the roadway at the same time.

Maintain local and emergency traffic at all times.

Maintain access to all private and public entrances within the work zone at all times.

Pedestrian Traffic

Pedestrian traffic passes under the east end of the bridge along the Sand Rock Cliffs Trail maintained by NPS. During structure work directly overhead of the trail or replacement of the riprap under the bridge, close the trail or flag pedestrian traffic through the work zone. Reopen the trail when work is not directly occurring in this area. Do not close the trail during non-working hours from Friday through Sunday or as directed by the engineer.

The walkway under the west end of the bridge is not an active trail and may be closed during project work.

Maintain pedestrian access across the bridge at all times.

Portable Changeable Message Signs

Install PCMS approaching the project limits as shown in the plans or as directed by the engineer seven calendar days prior to the beginning of project work.

Coordinate with the engineer three business days prior to deploying or changing a message on a PCMS to obtain approval of the proposed message. The engineer will review the proposed message and either approve the message or make necessary changes.

Wisconsin Lane Closure System Advance Notification

Provide the following advance notification to the engineer for incorporation into the Wisconsin Lane Closure System (LCS).

8. Environmental Protection, Dewatering.

Add the following to standard spec 107.18:

If dewatering is required, treat the water to remove suspended sediments by filtration, settlement or other appropriate best management practice prior to discharge. Submit the proposed means and methods of dewatering for each required location for approval as part of the Erosion Control Implementation Plan (ECIP). Include details of how the intake will be managed to not cause an increase in the background level turbidity prior to treatment and any additional measures necessary to prevent sediments from reaching the project limits or wetlands and waterways.

9. Environmental Protection, Aquatic Exotic Species Control.

Exotic invasive organisms such as VHS, zebra mussels, purple loosestrife, and Eurasian water milfoil are becoming more prolific in Wisconsin and pose adverse effects to waters of the state. Wisconsin State Statutes 30.07, "Transportation of Aquatic Plants and Animals; Placement of Objects in Navigable Waters", details the state law that requires the removal of aquatic plants and zebra mussels each time equipment is put into state waters.

At construction sites that involve navigable water or wetlands, use the follow cleaning procedures to minimize the chance of exotic invasive species infestation. Use these procedures for all equipment that comes in contact with waters of the state and/or infested water or potentially infested water in other states.

Before using equipment on this project, thoroughly disinfect all equipment that has come into contact with potentially infested waters. Use the following inspection and removal procedures:

- 1. Before leaving the contaminated site, wash machinery and ensure that the machinery is free of all soil and other substances that could possibly contain exotic invasive species;
- 2. Drain all water from boats, trailers, bilges, live wells, coolers, bait buckets, engine compartments, and any other area where water may be trapped:
- 3. Inspect boat hulls, propellers, trailers and other surfaces. Scrape off any attached mussels, remove any aquatic plant materials (fragments, stems, leaves, seeds, or roots), and dispose of removed mussels and plant materials in a garbage can before leaving the area or invested waters; and
- 4. Disinfect your boat, equipment and gear by either:
 - 4.1. Washing with ~212 F water (steam clean), or
 - 4.2. Drying thoroughly for five days after cleaning with soap and water and/or high pressure water, or
 - 4.3. Disinfecting with either 200 ppm (0.5 oz per gallon or 1 Tablespoon per gallon) Chlorine for 10-minute contact time or 1:100 solution (38 grams per gallon) of Virkon Aquatic for 20- to 30-minute contact time. Note: Virkon is not registered to kill zebra mussel veligers nor invertebrates like spiny water flea. Therefore, this disinfect should be used in conjunction with a hot water (>104° F) application.

For bridge seat protection/sealing, coat the tops of abutments with a type of epoxy resin the manufacturer recommends for sealing exterior concrete surfaces, subject to the engineer's approval.

C Construction

C.1 Blast Cleaning Operation

Blast clean the top surface of the abutment according to SSPC SP-13 and ASTM D4259 for an abrasive blast cleaning to a surface roughness and finish as the engineer directs. Before abrasive blast cleaning operations are to begin, prepare a representative trial area on the abutment surface, and have the method of blast cleaning approved by the engineer. Provide means of protecting bearings and girders such that their coatings/paint are not removed or damaged during blasting operations.

C.2 Water Cleaning Operation

After abrasive blast cleaning operations are completed, clean the prepared pier cap surface with water according to ASTM D4258. Remove with this water cleaning all dust and loose material from the top surface of the abutments to be coated with epoxy for bridge seat protection. Remove all loose concrete, dirt, dust, or blast material that remains in the area around the abutment, as the engineer directs.

The prime contractor is not allowed to withhold retainage from payments due subcontractors.

Payment to Lower-Tier Subcontractors

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

 - 4. For optimized concrete mixtures:
 - Complete the worksheets within DT2221 according to the directions.
 - Ensure the optimized aggregate gradations and the optimized mix design conform to WisDOT specifications and pass the built-in tests within DT2221.
 - Verify slip-form mixture workability according to AASHTO TP137 and conformance to specifications through required trial batching.
 - Submit the completed DT2221 to the engineer electronically. Include the trial batch test results with the mix design submittal.

Replace paragraph four with the following effective with the November 2021 letting:

- (4) Prepare and submit modifications to a concrete mix to the engineer for approval 3 business days before using that modified mix. Modifications requiring the engineer's approval include changes in:

- (1) Determine the complete gradation using a washed analysis for both fine and coarse aggregates. Report results for the 1 1/2", 1", 3/4", 1/2", 3/8", #4, #8, #16, #30, #50, #100, and #200 sieves.
- (2) Calculate blended aggregate gradations using the mix design batch percentages for the component aggregates. Ensure the blended aggregate gradation conforms to the percent passing by weight requirements of the combined aggregate gradation limits specified in table 501-4.
- (3) Throughout the contract, construct a 4-point running average of the percent passing by weight for each sieve to determine if the blended aggregate gradation is within the combined aggregate gradation limits specified in table 501-4.

 - 2. Perform corrective action documented in the QC plan or as the engineer approves.
 - 3. Document and provide corrective action results to the engineer as soon as they are available.
 - 4. Department will conduct two tests within the next business day after corrective action is complete.
 - 5. If blended aggregate gradations are within the tarantula curve limits by the second department test:
 - Continue with concrete production.
 - Contractor will include a break in the 4-point running average.
 - For Class I: Pavements, department will discontinue reduced frequency testing and will test at a frequency of 1 test per placement day. Once 5 consecutive samples are passing at the 1 test per placement day frequency, the reduced frequency testing will be reapplied.

- (3) Department and contractor will sample and test aggregate of the new mix design at the frequency defined in 710.5.6.1.

- (1) The department will make pay adjustments for strength on a lot-by-lot basis using the compressive strength of contractor QC cylinders or the flexural strength of contractor QC beams.
- (2) Randomly select 2 QC specimens to test at 28 days for percent within limits (PWL). Compare the strengths of the 2 randomly selected QC specimens and determine the 28-day sublot average strength as follows:
 - If the lower strength divided by the higher strength is 0.9 or more, average the 2 QC specimens.
 - If the lower strength divided by the higher strength is less than 0.9, break one additional specimen and average the 2 higher strength specimens.

715.3.2.2 Removal and Replacement

715.3.2.2.1 Pavement

- (1) If a sublot strength is less than 2500 psi in compressive strength or 500 psi in flexural strength, the department may direct the contractor to core that sublot to determine its structural adequacy and whether to direct removal.

- (5) The sublot pavement is conforming if the compressive strengths of all cores from the sublot are 2500 psi or greater.
- (6) The sublot pavement is nonconforming if the compressive strengths of any core from the sublot is less than 2500 psi. The department may direct removal and replacement or otherwise determine the final disposition of nonconforming material as specified in 106.5.

715.3.2.2.2 Structures and Cast-in-Place Barrier

- (1) The department will evaluate the sublot for possible removal and replacement if the 28-day sublot average compressive strength is lower than f'c minus 500 psi. The value of f'c is the design stress the plans show. The department may assess further strength price reductions or require removal and replacement only after coring the sublot.
- (2) The engineer may initially evaluate the sublot strength using a non-destructive method. Based on the results of non-destructive testing, the department may accept the sublot at the previously determined pay for the lot, or direct the contractor to core the sublot.
- (3) If the engineer directs coring, obtain three cores from the sublot in question. Have an HTCP-certified PCC technician I perform or observe core sampling according to AASHTO T24. Determine core locations, subject to the engineer's approval, that do not interfere with structural steel.
- (4) Have an independent consultant test cores according to AASHTO T24.
- (5) The department will assess concrete for removal and replacement based on a sublot-by-sublot analysis of core strength. Perform coring and testing, fill core holes with an engineer-approved non-shrink grout or concrete, and provide traffic control during coring.
- (6) If the 3-core average is greater than or equal to 85 percent of f'c, and no individual core is less than 75 percent of f'c, the engineer will accept the sublot at the previously determined pay for the lot. If the 3-core average is less than 85 percent of f'c, or an individual core is less than 75 percent of f'c, the engineer may require the contractor to remove and replace the sublot. The department may direct removal and replacement or otherwise determine the final disposition of nonconforming material as specified in 106.5.

715.3.3 Aggregate

Replace the entire text with the following effective with the November 2021 letting:

715.3.3.1 General

(1) Except as allowed for small quantities in 710.2, test aggregate conforming to 710.5.6.

715.3.3.2 Structures

- (1) In addition to the aggregate testing required under 710.5.6, determine the fine and coarse aggregate moisture content for each sample.
- (2) Calculate target batch weights for each mix when production of that mix begins. Whenever the moisture content of the fine or coarse aggregate changes by more than 0.5 percent, adjust the batch weights to maintain the design w/cm ratio.

716.2.1 Class II Concrete


