NOTICE TO CONTRACTORS**

BIDDERS MUST SUBMIT BIDDING PROPOSALS NO LATER THAN 11 A.M. LOCAL TIME TUESDAY, FEBRUARY 10, 2026 to the Division of Transportation System Development for the highway work hereinafter described.
