Deleted 5-1-5, Federal Grants and Development Process, because it is out-of-date and WisDOT no longer does this activity. Also deleted Attachments 5.1-5.3. Deleted 5-1-10, Review of Environmental Documents Prepared by Other Agencies. Deleted 5-1-15, Scoping Process. The content of 5-1-15 is covered elsewhere in FDM 3-25-1 and FDM 20-30-5, as well as in other places.

Section 5-5 Other Federal Agencies

Deleted 5-5-10, Department of the Interior, because the information is already covered in FDM 20-30 and 20-45. Deleted 5-5-15 regarding the Coast Guard because the content in that section is also found in FDM 20-50.

Section 5-10 State Agencies

Deleted 5-10-20, Office of Commissioner of Railroad (OCR), because the information is covered in FDM Chapter 17.

Section 5-15 Local Agencies

Section 11-15 Cross-Section Elements for Modernization Projects on Rural Highways, Freeways and Interstates Revisions in 11-15 pertain to clearing up confusion for rehabilitation and modernization projects. Attachments 1.1-1.18 have the word 'modernization' removed, so the only change shown is the date in red font.

Section 11-20 Cross Section Elements for Modernization of Urban Highways

Revisions in 11-20 pertain to clearing up confusion for rehabilitation and modernization projects. 11-20 also has changes that are in reference to curb extensions (adding a new subsection of 11-20-1.7.2). Attachment 1.1 has the word 'modernization' removed, so the only change shown is the date in red font.
