The Environmental Process and Documentation Section was the section responsible for FDM 5, however not all content in FDM 5 falls within the work area of the environmental sections. Additionally, many sections of FDM 5 were out of date, no longer applied to how WisDOT does coordination, and in need of modernization. The parts of FDM 5 that were no longer applied to WisDOT functions were deleted in a previous FDM update. The parts of FDM 5 that related to environmental documents or agency coordination as part of environmental documentation will be moved to FDM 20 and then edited/updated later this year in a future FDM update. The part of FDM 5 relating to the WisDOT-FHWA stewardship and oversight agreement has been assigned to the appropriate WisDOT section and will move to another part of the FDM in the future. Only Section 5-2 remains.
